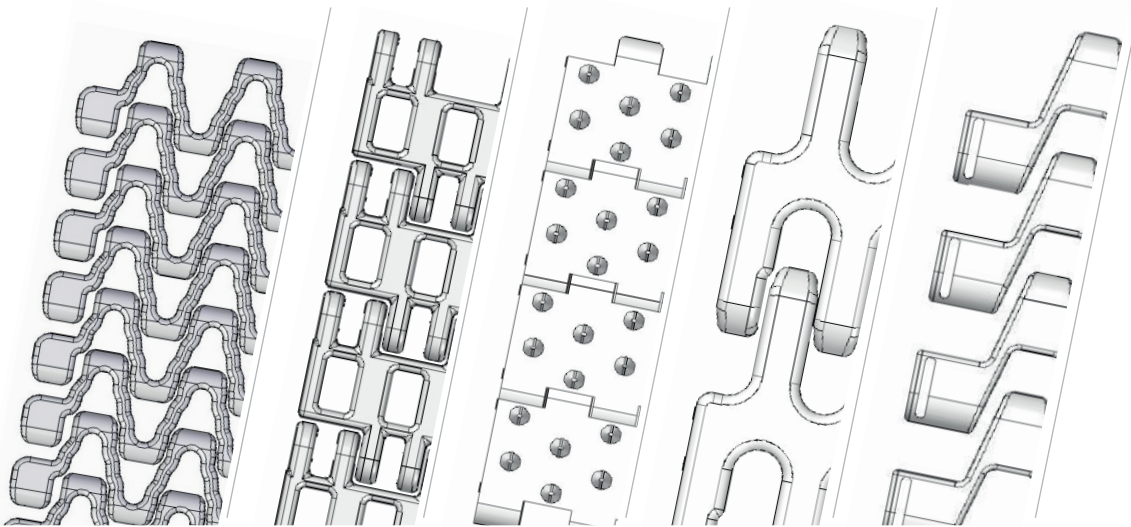

The grey and the blue belts contain:

The blue belt furthermore contains:

Ref no. 68320, **CAS no. 2082-79-3**, octadecyl 3-(3,5-di-tert-butyl-4-hydroxyphenyl)propionate, SML = 6 mg/kg

The product does not contain a functional barrier as defined in Regulation **10/2011/EC**

Overall migration tests have been conducted according to the specifications set out in EC-directives 85/752/EC as amended and 82/711/EC as amended.

The product can be in contact with all kinds of foodstuffs for a maximum of 1 hour at maximum 66°C.

Substances listed in Annex XIV of Regulation 1907/2006/EC (REACH) are not present in the mentioned product.

The item does not apply any danger to health or environment according to article 3 in Framework Regulation **1935/2004/EC**. The item is manufactured according to Regulation 2023/2006/EC on good manufacturing practice. The item complies with current EU-legislation on plastic materials and articles intended for food contact as described in **EC Regulation 10/2011/EC** and the Danish executive order no. 579 of 01/06/2011.
